RESOLUTION

OF THE MUNICIPAL LEGISLATURE OF SAN JUAN, IN REPRESENTATION OF ITS CITIZENS, TO RECOGNIZE AND TO CONGRATULATE THE HONORABLE BARACK H. OBAMA, JR., FOR HIS ELECTION AS PRESIDENT OF THE UNITED STATES OF AMERICA; AND FOR OTHER AIMS.

- WHEREAS: The major goal of President Abraham Lincoln to enforce the Declaration of Independence of the United States, which proclaimed the equality of all men, was initiated with the Emancipation Declaration (in 1863) and subsequently with the triumph of Union over Confederate forces (in 1865), has evolved with the election of Barak H. Obama Jr., a U.S. Senator of African-American origin and representative of Illinois minorities, to the position of President of our Nation;
- **WHEREAS:** The story of democratic Senator Obama is the manifestation of that we call *American Dream*, a story of perseverance that has culminated on November 4, 2008, after he won the presidential elections;
